Terms & Conditions:

- 1. The tender should enclose along with their request on letter pad of firm for issue of tender documents (Bank Draft/BA-16 + Taxes as applicable i.e. GST @18% i.e. 1180/- (non-refundable).
- 2. Earnest money @2% of estimated tender cost subject to a minimum of Rs. 5000/-. DD in favor of ME DIV PSEB VERKA, payable at Amritsar.
- 3. The tender shall be issued to those tenderer who have an active GST Number. PSPCL GSTIN No. is 03AAFCP5120QIZC. GST as applicable should be paid extra.
- 4. Conditional tenders will not be accepted.
- 5. The competent authority reserves the rights to reject any or all tender without assigning any reason.
- 6. In case the date of opening of tenders happens to be a holiday the tender will be received and opened on the next Working day at the same time.
- 7. The quotation received after the due date and time will not be considered.
- 8. No overwriting should be made in quotation. Any cutting must be attested by full signature and rubber stamp of the firm.
- 9. The quotation should be kept in three separate sealed envelope, one for tender document fees, one for technical specifications and the third for price bid.

- 10. The following procedure will be adopted for the opening of tenders.
- a. Part-I-Earnest Money: The first part will, consist of tender fees & earnest money.
- b. Part-II-Technical/Commercial bids: The second part will consist of commercial and technical conditions; firstly the envelope containing earnest money shall be opened and if the earnest money of any bidder is not found as per Tender requirement, the IInd part i.e. technical bid shall not be opened and Tender shall be cancelled. The firm should have labour license ,PAN, EPF, ESI, Active GST & proof of all should be submitted as Technical/Commercial documents.

c. Part-III: Price Bids:,

The Third part will consist of price. Tenderer qualifying in Part-I & Part-II Bid only will be considered for PART-III Price Bid. The price bids of the tender of all the eligible bidders shall be opened at pre-notified date and time. Price bid components of their bid should only contain prices so that there is no controversy regarding interpretation of any condition/stipulation at the time of preparation of merit statement after opening the price bid. Contractor should submit the bid as following:-

- 11. Security Deposit @5%will be deducted from each running and final bills after adjusting the earnest money deposited.
- 12. The Service of PTS will be not regularized.
- 13. The no. of PTS may decrease & increase as per requirement.
- 14. Tenders documents shall be issued to only those tenderers Who prima facie meets aforesaid qualifying requirement. However, Issue of tender documents shall not automatically construe qualification of the tenderer for the award of the work which shall again be determined during bid evaluation.
- 15. Contractor must submit bill to ASE/Sr. Xen, ME Division for whole Month i.e. from 1st date on month to Last date of month. Contractor is required to submit previous months Statutory Payments deposit Receipts Such as GST, EPF and ESI etc. along with bill wise detail of GST and employee wise detail of EPF,ESI.
- 16. The personnel to be hired from Contractor will be deemed to be their employee for all intents and purposes. It is duty of CONTRACTOR to certify that personnel provided by CONTRACTOR are of good moral character and they have no criminal record & no departmental as well as judicial proceedings were initiated against them earlier.
- 17. CONTRACTOR shall be responsible for ensuring compliance of provisions of all enactments, laws, rules and instructions in force and applicable to it from time to time pertaining to labour laws and other statutes. CONTRACTOR should maintain all records as stipulated by law. These records will be open for inspection by the concerned offices of PSPCL in order to ensure strict compliance of statutory provision. CONTRACTOR will also indemnify PSPCL on account of any loss suffered by PSPCL due to any omission or commission on the part of CONTRACTOR in discharge of its contractual and legal obligations during the validity of the contract. Any excess payment made to CONTRACTOR erroneously will be promptly returned. The Contractor shall

submit documentary proof of concerned offices separately in support of deposit of EPF, ESI ,GST etc. with bill of next month to satisfy the PSPCL that all deductions have been made deposits & credit in to the accounts of the concerned staff. The Contractor shall supply EPF statements to PSPCL with bill of next month.

- 18. The wages of PTS are based upon minimum wages notified by the concerned Deputy Commissioners. In case of the minimum wages as revised by the Deputy Commissioner from time to time will be payable to CONTRACTOR during the contract period. Contractor must submit the bill 1st of every month and credit wages of workers upto the 10th of every month in their bank accounts. That CONTRACTOR would ensure observance of strict discipline to the duties and other instructions issued by PSPCL from time to time. CONTRACTOR personnel should be very polite and punctual and under no circumstances be under the influence of any intoxicating drink or drug. PSPCL have the right to discontinue the services of the hired personnel if his behavior is found unsatisfactory. In case of misbehaviors or indiscipline by the hired personnel the matter should be reported immediately to CONTRACTOR. CONTRACTOR will re-call the delinquent personnel and replace him with new personnel and take suitable disciplinary action against the delinquent personnel.
 - That during the period of agreement remains in force the CONTRACTOR shall be responsible for any physical, economical, mental or otherwise loss, suffered by all or any of the personnel employed by CONTRACTOR. The PSPCL shall not be liable to pay any damages or compensation whatsoever to the employees of CONTRACTOR or to CONTRACTOR, for any death, injury or accident caused during the performance of duties envisaged under the agreement.
 - 20. In case of any dispute or difference arising out of the implementation or interpretations of any of the clauses of this agreement which may arise between the parties here in relating to the said agreement are subject to the ME Division, Amritsar jurisdiction only.
 - 21. Notwithstanding anything contained elsewhere in the agreement, agreement can be terminated at any time by either party by giving to the other one month's notice in writing or payment in lieu thereof.

2. The above contract can be extended twice after successful completion of original contract with the approval of Competent Authority.
