TERMS AND CONDITIONS:-

- The Societies/Contractors should be registered with EPF commissioner & possess (A) independent EPF A/C Number.
 - The Society should be registered with Registrar Co-op Societies Punjab. (B)
 - The L/C Co-op Societies should be enlisted with Punjab PWD (B&R), MES, (C) Irrigation Deptt. or any other Govt. Deptt.
 - The societies/contractors should posses:-(D)
 - PAN No. is essential (i)
 - GST No. is essential (ii)
- The Contractors should have registered with Pb. Govt./Central Govt. Deptt. such as 2. PSPCL/PSTCL, PWD Pb., Pb. IB, MES,CPWD, Railway etc. (essential) for appropriate class/financial limit.
- A set of tender documents (non transferable) consisting of specification & general terms & 3. condition can be obtained from the office of undersigned against payment of Rs. 12/- for upto 50000/-, Rs. 59/- up to 1,00,000/-, Rs. 590/- from Rs 1 lakh to 2 lakhs & Rs. 1180/- from 2 lakh to 1 crore (non refundable) including GST @ 18% by cash or in shape of demand draft in favour of Resident Engineer/(Op), UBDC PSPCL Malikpur on any working day.
- The bidder shall furnish attested photo copy of Income Tax return from the competent authority 4. along with his tender.
- Every tenderer shall produce along with his tender a solvency certificate from scheduled bank 5. where his firm's a/c is being maintained.

- Societies & contractors must submit affidavits that they have not been blacklisted by any Govt.
- 6. Agency.
- Conditional tenders, the tender received telegraphically, through Fax/ Telex and tenders without 7. earnest money shall not be accepted.
- The competent authority reserve the right to reject any or all the Tenders received without 8. assigning any reasons what so ever.
- PSPCL Works Regulation-1997 & its Amendment will be applicable, a copy of which can be 9. downloaded from PSPCL website.
- In case three nos. valid tenders are received from L/C co-operative societies, only these tenders 10. shall be considered. However, if no. of valid tenders from L/C co-operative societies found less than three, tenders from contractors will also be considered for evaluation.
- Tenderers will have to comply with all rules & regulations of under factory Act, Industrial Dispute 11. Act, EPF Act, Labour Laws, Bonus Act, Retrenchment Act, Building and other Construction workers (Regulation of Employment and condition of service) Act and Building and other construction workers welfare cess Act etc. as applicable, on his appointment for the above said work.
- 12. Security Deposits:- The earnest money deposited at the time of tender shall be converted into Security Deposit. The Security Deposit will be deducted from the running bills at the rate of 5% of the gross value of the work done from time to time after taking into account the EMD converted as Security. No interest shall be payable to contractors on the amount of security deposit. On the faithful execution of contractor in all respect the security deposit of the contractor shall be refunded after the expiry of warranty/defect liability periods as provided in the contract. In the case of civil works minimum periods of 6 months from the date of completion of work will be provided as defect liability period in the contract. In the event of fault on the part of contractor in faithful execution, the security deposit shall be forfeited by an order of contracting agency.
- 13. Income Tax, Labour cess shall be deducted at source as per prevailing rules and rates.

PSPCL is registered centrally in the state under GSTIN 03AAFCP5120Q1ZC. 14.

- GST. as applicable, will be paid as per prevailing provisions of GST Act. & Laws against submission of documentary proof at rate(s) prevailing during the contracted delivery period on the basis of actual. The following certificates shall have to be furnished along with invoice-cum-gate pass duly signed by the authorized agent/signatory.
- Certified that the transaction on which the GST is claimed has been/shall be included in the return submitted/to be submitted under GST law and the amount claimed from the Punjab State Power Corporation Ltd. has been deposited/shall be deposited with GST Authorities.
- Certified that the supplies on which GST has been charged have not been exempted under GST Act or rule made there
- under and that GST charged on these supplies is not more than what is payable under the provisions of relevant act.
- Certified that we shall indemnify the Punjab State Power Corporation Ltd. in case, it is found at a later stage that wrong or incorrect payment had been received on account of GST; the same will be refunded.
- Certified that we are registered under the GST Act and our Registration No. is _____

- Further any loss due to non-availability of ITC or levy of penalty/interest payable by PSPCL on account of non-filing of return or non-compliance or any miss-statement given under the provisions of GST ACT by the contractors shall be recoverable from them.
- 15. If the contractor fails to complete the work within stipulated period he shall be liable to pay one half percent the cost of work per week or part thereof the work remains unfinished after the contract completion period the penalty @ 0.5% per week you subject to maximum 10% of estimated cost of the work or actual cost of work whichever is higher.
- 16. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which tenders are invited should be either of the following: -

a) Three similar completed works costing not less than 40% of estimated cost i.e. 1.82 lacs each.

or

b) Two similar completed works costing not less than 50% of estimated cost i.e.2.27 lacs each.

or

- c) One similar completed work costing not less than 80% of estimated cost i.e. 3.63 lacs each
- 17. The payment will be made through RE UBDC against running bills approved by Sr.XEN/Civil for the actual work done.
