**NAME OF WORK:** Work of Regrading of Tile Terracing and repair of parapet and chajjas of quarters and offices at 66 KV Grid Colony PSPCL, Patiala.

**TERMS & CONDITIONS:**

- 1) Earnest Money subject to a minimum of Rs.9700/- and maximum of Rs 10 lac for Contractors and Co-op. L&C Societies.
- 2) Completion period: 1 year From date of issue of Allotment Order.
- 3) The detailed set of NIT specifications will be available in the office of Sr. Xen/Civil Mtc. Cell-I, PSPCL, Patiala on payment of Rs. 590/- (inc. GST), non refundable for each set in cash or through crossed demand draft in favour of Sr. Xen/Civil Mtc.Cell-I, PSPCL, Patiala.
- 4) Tenders of such bidder who do not purchase the set of NIT specifications shall not be opened.
- 5) Earnest money only in the form of PSPCL cash receipt or crossed demand draft in favors of Sr. Xen/Civil Mtc.Cell-I, PSPCL, Patiala, of any scheduled bank (except Canara Bank and Yes Bank) payable at Patiala must accompany the tenders in separate envelope.
- 6) Tenders without earnest money shall not be opened.
- 7) Tender documents shall be issued only to those tenderers who prima facie met the qualifying requirements. However issue of tender documents shall not automatically construe qualification of the tenders for allotment of work, which shall again be determined during bid evaluation.
- 8) PSPCL reserves the right to reject/accept any or all the bids received at its discretion without assigning any reason what so ever.
- 9) Tenders shall be valid for acceptance up to 120 days from the date of their opening.
- 10) Tenders received telegraphically/ through fax/ through telex/ through email/ through telephone or incomplete tenders shall not be accepted.
- 11) If the fixed day for tender opening happens to be a holiday, the tenders will be opened at same time on the next working day in the presence of contractors/societies or their representatives who so ever like to stay there.
- 12) Chargeable to Estimate for annual M&R of 66KV Grid Colony, PSPCL, Patiala.
- 13) The contractors shall be enlisted with PSPCL/PSTCL upto Rs 10 Lac as B class Contractor or equiv. in Pb. PWD(B&R)/CPWD/MES/ Railway & labour & construction societies shall be enlisted with PWD(B&R) only.
- 14) The labour & construction societies /contractors shall have EPF registration No. from RPF commissioner /Asstt. Provident fund commissioner.
- 15) The labour & construction societies /contractors shall have GST no.
- 16) The labour & construction societies /contractors shall have PAN.
