Sr. Pre qualification requirement

No. I. Registration:- Contractor/L&C society should be registered / enlisted for the execution of Civil Works with PSPCL, PSTCL, PWD, Railway, MES, NTPC, Central Govt. or other such organizations for works of ₹ 2 lacs & above on or before the due date for uploading the tenders.

Firm already registered with GGSSTP/GHTP/NTPC or other such Central/State govt. organization shall have to fulfill PQRs, all clauses of the NIT/Tender specifications of the tender and shall submit self-attested hard copies of proof of valid registration along with other documents for further participation in the tender. Their participation in the tender will only be considered if the documents submitted are found in order.

II. Experience:- Experience of having successfully completed/ executing Civil Mtc. & construction jobs/Housekeeping jobs during last 7 years ending 28-2-2025 should be either of following :

- a) One similar completed/being executed work costing not less than the amount equal to ₹ 1.00 lacs or
- b) Two similar completed/being executed work each costing not less than the amount equal to ₹ 0.60 lacs or
- c) Three similar completed/being executed work each costing not less than the amount equal to ₹ 0.50 lacs

NOTE:-

1. Work order value shall be considered on one year basis.
2. In case work order period falls beyond the seven year period then proportional amount of work order value will be considered as executed work, against the work order.
3. Completion certificate of work done in any department is must against each completed work.
4. In case work order (s) is/are under execution as on the date of 28-2-2025 the value of work completed till 28-2-2025 will be considered provided the value of executed work is certified by the work order issuing authority.

II. Annual turnover:- Proof of having average annual turnover during last 3 years, ending 31st March of the previous financial year, should be at least ₹ 1.00 lacs.

V. Bank solvency:- Every bidder shall produce along with his tender a solvency certificate for minimum value of Rs. 2.0 Lacs from scheduled Bank where his firm's account is maintained. Bank solvency certificate should not be more than 12 months old. If he fail to produce such a certificate his tender may not be considered.

V. Balance sheet:- Audited balance sheet for last three financial years.

I. Proof of having EPF A/c No.

EPF clearance certificate:- EPF clearance certificate for last two financial years needs to be obtained. In the event of non-availability of clearance certificate proof of deposit of EPF for last two years shall be attached.

I. Proof of having ESIC code.

I. Proof of having GST registration No.

I. Copy of PAN as proof of having PAN No.

Affidavit: : an affidavit in original duly attested by executive magistrate/ Notary public to affect that :-

(A) Declaration regarding that the firm had not been defaulter in respect of EPF/ESI to the concerned EPF/ESI department for the worker deployed against work order placed by PSPCL or any other organization on it during the last five years. In any case, the responsibility for deposition of EPF/ESI of workers engaged by firm shall rest with firm only.

(B) That the firm has not been blacklisted by any Govt/public sector undertaking during last 5 years.

1) As per Pb. Govt. notification dtd 04.11.2019 issued by Registrar Co-operative Societies Punjab, preference will be given to Co-op Societies for participation in this tender. 2) If any

fresh Pb. Govt. notification is issued by Registrar Co-operative Societies Punjab regarding any preference/relaxation to Co-op Societies for participation in tenders, till the last date of uploading the tender, the same shall be applicable for this tender also.

3) If the bidder is registered under MSMED Act-2006 than the bidder will submit documentary evidence of being a Micro, Small & Medium Enterprises. If the bidder does not submit the proof at the time of submission of its bid, it shall be considered as a Large Enterprise.

Note:- The bidder registered under MSMED Act-2006 are not exempted from depositing tender Fee and EMD as per NIT.

1. Contractors/firms desirous to take part in the tenders can also get themselves registered with Civil Mtc. Circle by sending their application to the O/o Addl.SE/PCM Divn GGSSTP Rupnagar at least 15 days prior to the last date uploading of tender along with DD of Rs. 1180/- including GST (Rs. One thousand one hundred eighty only) in favour of AO/O&M, GGSSTP, payable at Rupnagar along with the requisite documents as mentioned above from sr. no. II to XI.


1. Contractors/firms desirous to take part in the tenders can also get themselves registered with Civil Mtc. Circle by sending their application to the O/o Addl.SE/PCM-1 Divn GGSSTP Rupnagar at least 15 days prior to the last date uploading of tender along with DD of Rs. 2360/- including GST (Rs. Two thousand three hundred sixty only) in favour of AO/O&M, GGSSTP, payable at Rupnagar along with the requisite documents as mentioned above from sr. no. II to XI.

2. After opening of Price bid, Reverse Bidding (as per clause 21 of Terms & conditions of NIT) among qualified bidders shall be carried out to arrive at the lowest evaluated Bid. Date & time will be intimated to the qualified bidders.

3. Further, once a bidder is found to have lowest evaluated techno- commercially responsive bid (after the Reverse Bidding process) may be called for further negotiation of prices. Negotiations, if any, will be held with the lowest bidders only arrived after reverse bidding.

4. The bidders registered with concerned circle are not required to upload EPF A/c No. ESIC A/c No., GST No. PAN No.

5. The existing man power against the existing work order should not increase in any case. The contractor will not deploy any new person during the pendency of contract however, he can deploy new worker against retirement/death of any worker already working in the work order only with the approval of Competent Authority. The upper age limit for workmen employed shall be fixed at 60 years.

TERMS AND CONDITIONS:

- 1.0** The work shall be got executed by Addl. Superintending Engineer/ Plant Civil Mtc. Division -2, GGSSTP, Rupnagar
- 2.0** Goods Services Tax
GST as applicable in law of Service Tax shall be paid extra by PSPCL against documentary proof.
- Certified that the transaction on which GST is claimed has been/shall be included in the return submitted/to be submitted under GST law and the amount claimed from PSPCL has been deposited/shall be deposited with GST authorities.
 - Certified that the supplies on which GST has been charged have not been exempted under GST Act on the rule made there under and that GST charged on these supplies is not more than what is payable under provisions of relevant act.
 - Certified that we shall indemnify the PSPCL, In case, it is found at a later stage that wrong or incorrect payment has been received on account of GST, the same will be refunded
 - Certified that we are registered under GST Act and our registration no. is _____
 - Further any loss due to non-availability of ITC or levy of penalty/Interest payable by PSPCL on account of non-filing of return or non-compliance or any miss-statement given under the provisions of GST Act by the contractor shall be recoverable from them
- 3.0** Contract Period:- 30 Days
- 4.0** The quoted rates shall include all overhead charges, statutory benefits payable to the workers deployed by the contractor as per various labour laws and all taxes and levies excluding GST, which shall be reimbursed.
- 5.0** The Contractors/Bidders with consortium are not eligible.
- 6.0** The Contractors/Bidders shall quote in Indian Rupees Only.
- 7.0** Those Contractors/ Bidders whose contracts have been terminated /foreclosed by PSPCL due to unsatisfactory execution of the contract with PSPCL during the last 5 years are not eligible to participate in the bid.
- 8.0** Bid documents are not transferable. Bid shall be received from only those contractors/bidders who are registered with GGSSTP and in whose name the bid document has been issued after scrutiny and verification of the Application in support of pre-qualifying requirements as per NIT.
- 9.0** Bids shall be valid for a period of 120 days from the date of opening of price bid.
- 10.0** Bids with stipulations for settlement of dispute by reference to arbitrations shall be rejected.
- 11.0** Corporation reserves the right to verify the information / documents furnished in respect of works carried out by the contractor/bidder should the circumstances so warrant.
- 12.0** Corporation will not be responsible for delay in uploading the tender.
- 13.0** Corporation reserves the right to accept or reject any or all bids without assigning any reason.
- 14.0** Conditional tenders, telegraphic, through telex, fax tenders, tenders not on prescribed forms or tenders without earnest money in the required shape shall not be accepted.
