TERMS AND CONDITIONS:

1. A set of tender documents (non-transferrable) containing scope of work and terms & conditions can be obtained from the office of SE/Headquarter, GGSSTP P.O. Ghanauli Ropar Punjab 140113 by remitting its cost (non-refundable) in cash or through demand draft in favour of AO/GGSSTP, PSPCL Ropar payable at Ropar. Tenders of those bidders who have purchased the specifications shall only be opened and considered
2. Tenders received through telegraph, email, telex, fax, conditional tender or manually shall not be considered at all.

3. PQR:-

- A) Tenders of only those technically suitable firm /contractor will be considered who are registered with PSPCL/PSTCL, NTPC and other such central Govt. organizations (on submission of valid registration certificate) for the jobs of:- "Maintenance/repair/Fitment of pumps AND/OR fabrication of pump spares."
- B) The firm should have proof of having successfully completed/being executed the jobs of:
- C) "Maintenance/repair/Fitment of pumps AND/OR fabrication of pump spares." at Thermal/ Nuclear/ Gas power plants or other heavy industries like Petrochemical Plants, Cement manufacturing plant, Fertilizer Plant, Pharmaceutical Plant etc. during last 7 years ending 30.09.2025 either of following:-
 - a) Three same works as above costing (including all taxes) not less than Rs. 0.66 Lacs each.
OR
 - b) Two same works as above costing (including all taxes) not less than Rs. 0.79 lacs each.
OR
 - c) One same work as above costing (including all taxes) not less than Rs. 1.31 lacs each.

4. Requirement for registration:

Those tenderers who fulfils the requirement of PQR and consider themselves eligible for participation can get themselves registered with GGSSTP by submitting the attested copies of followings documents along with non-refundable registration fee of Rs. 1000/-+ GST@18% (Rs. One Thousand plus GST@18%) in cash receipt or through demand draft in favour of AO/GGSSTP, PSPCL, Ropar payable at Ropar fulfilling the following criteria:-

- (i) Copies of work orders and completion certificates for experience as per PQR.
- (ii) Copies of Audited balance sheets over during the last three financial years, ending 31st March of previous financial year.
- (iii) Bank solvency of minimum Rs. 2.62 Lacs. Bank solvency certificate should not be more than 12 months old.
- (iv) Average annual financial turn over during the last three year, ending March of the previous financial year, should be at least Rs. 1.31 Lacs.
- (v) Proof of PAN and Proof of Goods and service tax (GST) registration number.
- (vi) Proof of independent EPF account number.
- (vii) EPF clearance certificate: EPF clearance certificate for last financial year needs to be obtained. In the event of non-availability of clearance certificate proof of deposit of EPF for last two years shall be required.
- (viii) Proof of having ESI Code number.

(ix) An Affidavit in original dully attested by an Executive Magistrate/Notary to the effect that :

- The firm is not defaulter in respect of deposition of EPF/ESI to the concerned EPF/ESI department for workers deployed against work orders placed by PSPCL or any other organization on it during last five years. In any case, the responsibility for deposition of EPF/ESI of workers engaged by the firm shall rest with the firm only. In case firm is found defaulter at any stage in this regard, the contract shall be cancelled without any notice.
- That the firm has not been black listed by any government/public sector undertaking during the last 5 years.

(x) The registration of the firm will be done on the merit on the basis of credentials of the firm and decision of Chief Engineer/GM GGSSTP shall be final in this regard.

5. Tenders will be considered if the registration of the firm is done on or before the last date of bid submission. The request for registration by new firms must reach the office of registering authority at least five working days prior to last date of opening of tender documents.
6. Quotation/Tender should be enclosed in double covers both addressed to SE/Headquarter, GGSSTP, P.O: Ghanauli, Distt. Ropar (PB) PIN-140113. Both inner & outer covers shall be sealed and super scribed with Tender Enquiry No. as given on the enquiry/Tender Notice together with the date on which the tender opening is due and also the name of work.
7. Bid should be submitted in two parts.
Part 1: Tender document fee & Earnest Money Deposit
Part-II: Price bid.
8. Tenders received without Earnest Money shall not be opened.
9. In case the date of opening of tenders happens to be a holiday, the tenders will be received and opened on the next working day at the same time and place.
10. Tenders of those firms shall be rejected who are blacklisted or with whom business dealings are suspended by PSPCL.
11. Contract Executing office: ASE/MA, Mech. Mtc. Circle-I, GGSSTP, Ropar.
12. In case of any dispute regarding issue of tender documents or any other dispute, CE/ GGSSTP, Ropar shall be the final authority and no claim on this account shall be accepted.
13. The rates should be quoted as per Rate quoting Performa Annexure-III.
14. Complete details of tender specifications as per terms & conditions along with performa for quoting rates and scope of work are to be purchased by the bidder before quoting rates.
15. The tender evaluation shall be done on the basis of overall lowest rates.
