Sub: Introduction of Time of Day (T.O.D.) Tariff for Large Supply Industrial Consumers from October to March every year (six months).

As per directions of Hon'ble Tariff Commission, proposal for introduction of time of the day (T.O.D.) tariff was submitted by PSPCL and the same was discussed with various consumers organizations & stake holders by the Commission. With the approval of revised tariff of various categories w.e.f. 01.04.2013, Hon'ble Commission has also approved the proposal for introduction of Time of the Day tariff for large supply Industrial Consumers from October to March every year (six months) and rebate of Rs.One / Unit on the normal tariff shall be allowed on consumption recorded during off peak hours from 22.00 Hours to 06.00 Hours. T.O.D. tariff will thus be introduced w.e.f. October 2013.

It shall thus be incumbent upon officers recording monthly consumption of large supply consumers to also get the data of consumption downloaded with the help of meter reading instruments and working out monthly consumption during off peak load hours of the month between 10 PM to 6 AM for allowing rebate @ Rs. One/ Unit by the CBC. Chief Engineers distribution may ensure to interact with CE/Metering for procurement of M.R.I.'s and making the officers conversant with the technique of data downloading as being done by the MMTS of Enforcement directorate so that issue of

bills do not get delayed by the C.B.C. In distribution divisions having large number of Large Supply connections, Chief Engineers/ Distribution system may depute other officers of the same circle for timely downloading the data of Large Supply Industrial Consumers.

Hon'ble Commission has also directed PSPCL to submit detailed report about the financial and technical impact of introducing T.O.D., by March 2014. Accordingly, Centralized Billing cells shall prepare details regarding amount recovered with the increase of PLEC w.e.f 01.04.2013 in line with PR circular No. 5/2013 dated 11.4.2013 and rebate allowed to large supply consumers for the period October 2013 to March 2014 on monthly basis and forwarded the same to CE/ARR &TR for preparing report. CE/Power Purchase & Regulation shall also keep watch on the monthly peak demand of the system during the period October 2013 to March 2014 and comparing the same with the peak demand of previous year, every month from October 2012 to March 2013 and submit the same with his comments to CE/ARR&TR for submission of report to the Tariff Commission.

The instructions as per above shall be followed by all the concerned officers meticulously.
