Stay on the operation of the amendment to Sub clause (c) of Regulation 21.2 of Supply Code appearing at Sr. No-3 of the Notification No.PSERC/ Secy/ Regu.82 dated 21 June, 2013, circulated by PSPCL vide CC no. 37/2013.

PSERC vide its Notification No.PSERC/ Secv/ Regu.82 dated 21 June. 2013 , circulated by PSPCL vide its commercial circular no. 37/2013 dated 26/7/13, had amended Regulation 21.2 (c) of Supply Code as under:-

21. Use etc. of Meters

21.2 Supply and installation of meters

c) The Licensee may require a meter to be installed outside the premises of a consumer and in such an event, the entire cost of installing the meter outside the premises and providing a display unit within the premises will be borne by the Licensee. However, the cost of display unit will be treated as part of the meter cost while determining meter rentals. The display unit may not be installed by the licensee if the consumer so opts. In such an event monthly rentals on this account will not be levied. In a case where the meter/metering equipment is installed by the Licensee outside the premises of a consumer, the consumer will not be responsible for the protection of the meter from theft or damage to the seals/meter or tampering of the seals/meter.

PSERC has now stayed the operation of the above amendment vide its Notification No.PSERC/ Secy/ Regu.84 dated 16 August, 2013 (copy enclosed), till further orders. The same may be bought to the notice of all concerned under your control for its meticulous compliance.
