Voluntary Disclosure Scheme for Domestic / Non-Residential Supply (DS/NRS) Consumers.

Keeping in view, overwhelming response of the VDS scheme introduced earlier for domestic consumers on 3/6/11, PSPCL has decided to reintroduce this scheme again for the domestic consumers and to launch fresh VDS for non-residential consumers also to give an opportunity to get their unauthorized load regularized. This has been done keeping in mind that the consumers covered under Schedule Domestic/Non Residential Supply extend their electrical installations for using modern gadgets like ACs, microwaves, decorative lighting, glow sign boards etc. but do not get their load regularized. In the absence of data of actual installed load, PSPCL is unable to upgrade the existing transmission and distribution system to cater the actual load. This leads to more interruptions / breakdowns of supply due to overloading of distribution system, causing avoidable inconvenience to our esteemed consumers. This scheme will be available for three months i.e up to 11/6/12. The salient features of VDS shall be as under:-

- There will be no checking of connected load during the period VDS remains in force and no penalty for unauthorized extension in load disclosed voluntarily shall be levied.
- ii) For the purpose of computing total connected load, the actual continuous rating of an apparatus/appliance connected to the wiring will be taken into account. However, the following standard wattage ratings will be adopted for assessing the connected load, if actual rating is not specified by the consumer.

NOTE

- The connected load of UPS indicated in KVA will be converted into KW by multiplying with the power factor of 0.9. However, sockets installed on the output side of UPS will not be taken into account.
- b) 3 phase power sockets for NRS/Industrial purposes will be taken as 6 kW each and half of the no. of sockets will be counted.
- c) Any fraction of lamp/socket will be counted as one.
- d) In case a single switch is used for controlling more than one lamp/ appliance, the sum of the total capacity of all the lamps/ appliances will be taken into account for computing connected load.
- e) The load of air conditioners/AC packages/centralized AC systems bearing ISI mark will be taken as per their nameplate. For non-standard air conditioners; the load of each will be taken as 2.5 KW.
- Service Connection Charges to be recovered against such declaration shall be as under:-

- Service Connection Charges and rates of Security shall be recoverable for the extension in load only. However, the total load (including extension) shall be considered for the purpose of determining slab rate of service connection charges and rates of Security.
- While regularizing the load under VDS, field officers shall ensure that the connection is not being misused by the consumer for any other purpose i.e. Industrial / AP etc.
- vii) After computing the load as mentioned above in ii), the consumer will submit A&A form along with Test Report and deposit requisite charges. During the VDS period, the load will be deemed to be regularized from the date of submission of A&A form alongwith the Test Report and requisite charges.

- viii) Augmentation of service line / transformer and the power system (including conversion from single phase to three phase) and change of meter etc shall be done by the PSPCL at its own cost.
- DS/NRS consumers shall be allowed to extend their load under VDS ix) subject to the condition that total load after extension will not exceed 100 KW.
- Mass awareness camps shall be arranged where the concerned x) officers/staff of DS organization shall be available to the public for regularization of extra unauthorized load on the spot, after accepting payment of initial Security, Meter security (if applicable) and Service connection charges.

The VDS scheme will be available only for three months i.e up to 11.6.2012 and shall not be extended further. During VDS period load surcharge for unauthorized load /extension will not be leviable and after closure of the scheme the Engineer-in-Chief/ Chief Engineer/Operation concerned shall furnish the following information to the Chief Engineer/Commercial for onward transmission to Hon'ble PSERC:-

- i. No. of consumers (separately under DS/NRS) categories) who availed the VDS
- Total Load declared under the scheme separately for DS and NRS categories.

iii. Amount received in respect of Service connection charges/initial security.
