Recruitment for the various posts against CRA No. 285/15 and 286/15 in PSPCL

In continuation to CRA 285/15 & 286/15 issued on 17.6.2015, candidates are hereby informed about the following additional instructions/ guidelines for the written test to be held by PSPCL:

1. Basic & Professional qualification for the post of LDC/ Cashier may be read as under:-

Bachelor's Degree from a recognized University or Institution.

AND

Possesses at least one hundred and twenty hours course with hands on experience in the use of Personal Computer or Information Technology in Office productivity application or Desktop Publishing application from a Govt. recognized institution or a reputed institution, which is ISO 9001 certified

OR

Possesses a Computer information Technology Course equivalent to 'O' level certificate of Department. Of Electronics Accreditation of Computer Courses (DOEACC) of Govt. of India.

2. Scheme of examination for the post of UDC (General) / Office Assistant (General) and LDC/ Cashier is given below:-

However scheme of examination for all the other remaining posts as per advertisement (except UDC (General) / Office Assistant (General) and LDC/ Cashier) shall remain the same.

3. a) Candidates are hereby informed that in case they fulfill the basic / professional qualification and other terms & conditions of CRA 285/15 & 286/15, they may apply for the multiple posts by using separate email ID by depositing separate fee (Non-refundable) for each post.

b) However, every effort will be made to arrange tests in such a way that every candidate may appear in maximum number of tests. Here, it is made clear that if due to any reason, any candidate is not able to appear in any of examination then mere applying for multiple posts does not entitle candidates to appear in all the examinations and no query or change in schedule of examination would be entertained under any circumstances.

4. It is intimated that medium for the following examination papers shall be bilingual i.e. English & Punjabi Language.

- a) Technician Grade-I
- b) Technician Grade-II
- c) Electrician Grade-I
- d) Junior Plant Attendant

Rest of the examination papers will be in English language.

5. Candidates / applicants possessing degree / diploma in Electronics & Communication are not eligible to apply for the post of JE/ Electrical, JE/ Sub Station, APA/ AJS Electrical against CRA 286/15.

Rest of the terms & conditions of CRA 285/15 and 286/15 shall remain the same.
