

ORDER

As per Tariff Order dated 27.07.2016 for PSPCL for FY 2016-17, the tariff structure mentioned therein is to remain operative till 31.03.2017. The determination of ARR of PSPCL for MYT Control Period from FY 2017-18 to FY 2019-20 is under process and is likely to take some more time. As such, the existing tariff structure is ordered to be continued for all categories of consumers w.e.f. 01.04.2017 till the date of issue of the Tariff Order for MYT Control Period from FY 2017-18 to FY 2019-20, subject to the condition that the Government of Punjab continues to pay subsidy to the Punjab State Power Corporation Limited in respect of the categories already being subsidized.

Further, the Commission in para 7.2.14(v) of the Tariff Order had decided, as a policy, to remove PLEC and approved following ToD Tariff for Large Supply industrial category consumers :-

(a) ToD tariff comprising of normal tariff plus additional charge as




approved by the Commission in the Tariff Order will be applicable during peak hours from 06:00 PM to 10:00 PM from 1st June to 30th September.

- (b) ToD tariff comprising of normal tariff minus rebate as approved by the Commission in the Tariff Order will be applicable from 10:00 PM to 06:00 AM (next day) from 1st October to 31st May of next year.

The Commission also decided to remove PLEC and approved ToD tariff for Medium Supply industrial category consumers, comprising of normal tariff minus rebate as approved by the Commission in the Tariff Order and ordered to be applicable from 10:00 PM to 06:00 AM (next day) from 1st October to 31st May of next year.


The Commission in the Tariff Order for FY 2016-17 for PSPCL, approved ToD tariff comprising of normal tariff (as per Schedule of Tariff for FY 2016-17) for FY 2016-17 minus ₹1.00 per kVAh for Large Supply and Medium Supply industrial category consumers from 10:00 PM to 06:00 AM (next day) from 1st October, 2016 to 31st March, 2017.


In view of the above, ToD tariff comprising of normal tariff (as per Schedule of Tariff for FY 2016-17) for FY 2016-17 minus ₹1.00 per kVAh will be applicable to Large Supply and Medium Supply industrial categories of consumers from 10:00 PM to 06:00 AM (next day) from 1st April to 31st May, 2017 or the date of issue of the Tariff Order for MYT Control Period from FY 2017-18 to FY 2019-20, whichever is earlier.





Further, Peak Load Exemption Charges (PLEC) shall not be applicable w.e.f 01.04.2017. The Additional charge of Rs. 2.00 per kVAh (as approved in the Tariff order for FY 2016-17 from 06.00 PM to 10.00 PM from 1st August, 2016 to 30th September, 2016) will not be applicable to Large Supply and Medium Supply Industrial Categories of Consumers from 01.04.2017 to 31st May, 2017.
