In view of the gap in demand and supply, the following power Regulatory Measures were announced / circulated to be applicable, starting with effect from 1.8.2012 to onwards, on all general and arc/ induction/ rolling mill consumers.

Special Instructions

1. Peak load exemptions to LS & MS category consumers fed from category-1 feeder, also remained suspended w.e.f. 1.8.2012 to 13.8.2012 and was relaxed as per sr. no. 6 (above table) remarks 2 & 3.

2. These regulatory measures are not applicable to Essential & other exempted category of consumers fed from Cat-2&3 feeders as mentioned in PR circular 12/98 and 6/2010.
3. Restricted Load up to the limit of 10% of the SCD is allowed to be used by category-2 & 3 consumers on their WOD/ restricted hours only.
4. The consumers can import Open Access power on their WODs as per their open Access agreements.
5. During suspension of peak load exemption for LS and MS consumers w.e.f. 24.7.12 onwards, the consumers are allowed to import open access power to the extent of peak load granted. The suspension is valid only for the use of PSPCL power.
6. Peak load exemption charges are not to be levied for the period during which peak load exemptions remained suspended, however the said charges are to be levied on prorate basis for the period during which peak load exemptions remained curtailed.
7. Days of weekly off day remains the same as mentioned in PR Circular No. 2/2010

General Instructions

1. The consumers are requested to download the information regarding peak load restrictions/ weekly off days from the PSPCL website. They are requested to visit the website of the PSPCL on regular basis, in future.
2. The field officers were requested to display the relevant circulars on the notice Boards of complaint centers as well as Sub Divn offices/Grid Sub Stations.
