In confirmation to various power Regulatory Telephone messages given on account of availability of power and Inter State Transmission System constraints, the following Power Regulatory measures remained applicable to LS Industrial consumer fed from Category-2 & 3 feeders during the month of July, 2011.

Note : 1) Reference message 318/11 dated 26.07.2011 it is clarified that w.e.f.26.7.2011 to 31.7.11 Arc furnace consumers are allowed to use load of 10% of their SCD in addition to 5% of their restricted load allowed to them during off peak hours on their weekly off days However, during peak load hours only the restricted load as per the entitlement is allowed

2) peak load exemption charges @ 50% to be charged for the period during which restriction on peak load exemptions remained applicable.

The consumers were requested to download the information regarding peak load restrictions/weekly off days from the PSPCL website. They were asked to visit the website of the PSPCL on regular basis in future.

The field officers were requested to display the relevant circulars on the notice boards of complaint centres as well as Sub Divn. offices/Grid Sub Stations.

The relevant information is also being conveyed to PSPCL field officers and selected representatives of industrial associations. The consumers could also get this information on telephone from field officers.
