- (iii) Experience: Minimum of three years' field experience in the relevant field.
- (B) In addition, applications can also be submitted by Chief Engineer or equivalent officer who have put in 30 years of total Group 'A' service and 3 years of qualifying service in SAG fulfilling that conditions regarding field experience and age limit as mentioned above.
- 2. The post of Member in the Central Electricity Authority carries the scale of pay of Rs.22400-525-24500/- (Pre-revised) [Rs.67000-79000 (Revised)] with ex-officio status of Additional Secretary to the Government of India. The incumbent of the post is entitled to other allowances/benefits as per rules of the Central Government.

  - (b) engineering with specialization in transmission and supply of electricity;
  - (c) applied research in the field of electricity;
  - (d) applied economics, accounting, commerce or finance.
- 5. The duties and responsibilities attached to the post of Member (Planning), CEA, are given in the Annexure-I.
- 6. The Member shall hold office during the pleasure of the Central Government. Appointment to the post would normally be made for a period of five years, which shall be restricted to the date on which the incumbent of the post attains the age of superannuation. The officer selected will not be eligible from permanent absorption in the CEA.
